



## Taste of Jamaica 2018 Raffle Terms and Conditions

### **Please read the following terms and conditions carefully**

1. Participation in the Jamaican Canadian Association Alberta's Taste of Jamaica Raffle 2018 costs \$5 per entry.
2. Profits from this raffle will support the work of the Jamaican Canadian Association Alberta which is a registered organization under the Alberta Societies Act.
3. The raffle is open to all adults (18 years and older) resident in the province of Alberta and is operated under licence # 486686 issued by the Alberta Gaming and Lotteries Commission (AGLC).
4. It is an offence for raffle entries to be sold to, or by, a person under 18 years of age. If anyone is found to be under 18, they will automatically forfeit their right to a prize.
5. Payment for participation in the raffle can be made by cash, cheque payable to the Jamaican Canadian Association Alberta or by credit/debit card. All sales are final.
6. All raffle tickets that are fully paid for will be entered in the draw.
7. The prize draw will take place on March 31, 2018 as part of the Taste of Jamaica event. Winning entries will be randomly drawn publicly. Prizes are as follows:
  - First prize: A Jamaican Vacation (flight and hotel)
  - Second prize: A Jamaican Rum Basket
  - Third prize: A Jamaican Food Basket
8. The first prize winner will receive two (2) tickets for airline travel to Montego Bay, Jamaica flying economy on a commercial airline. Also included is a maximum seven (7) days stay at a minimum 3-star hotel offering an all-inclusive package. The organizer reserves the right to use its own travel agent to book the choice of the commercial airline and hotel that are used to fulfill the winner's prize. There is no cash value for the prize. Prize is subject to black out dates and availability, prize must be booked a minimum of 2 months prior to travel. Prize cannot be transferred or sold to another person and terms and conditions are subject to change. Total cost for fulfilling the first prize package will not exceed four thousand (\$4000) Canadian dollars.
9. Prizes must be claimed within 180 days of the draw date (March 31, 2018) if not they are forfeited. The first prize package must be fulfilled within 365 days of the draw date. Prizes are not transferrable.
